PART I: TERMS AND CONDITIONS FOR BUYERS

We highly recommend that you read through the full B2B Buyer Program terms and conditions below:

Programme inclusions:

- **TWO NIGHTS ONLY** hotel accommodation (room & breakfast) only for your programme dates: 24th 27th November 2019, at Impiana KLCC Hotel.
- Ground transfers in Kuala Lumpur: between Kuala International Airport Terminal 1/2 Impiana KLCC Hotel.
- Access to the hosted buyer lounge (complimentary lunch)

Programme exclusions:

- Any personal extras at the hotel. These should be settled directly with the hotel upon your departure.
- Hotel upgrades.
- Taxi fares if arriving / departing outside hosted buyer programme dates.
- Visa application fees.
